#### 1. Welcome (President)

#### 2. National societies: Identification of delegates

All representatives were listed and their presence was confirmed. All present (31 votes), except for the Portuguese Society for Microscopy.

Board members were present but they were not entitled to vote. Only council members are entitled to vote.

#### 3. Main objective of the meeting: EMC2020

The main subject of the meeting was to decide on the future of EMC2020 due to the COVID19 situation. To date, EMC2020 has been cancelled.

The different options on the future of the meeting were analysed and after a discussion a final decision was aimed at by a vote from the council members.

## 4. EMC2024 projection (Prof. Klaus Qvortrup, EMC2020 President)

The meeting has been cancelled for 2020 at Bella Centre due to the current COVID19 situation by the Danish authorities.

New possible dates available for EMC2024 at Copenhagen: 26-30 August, 2024 or (optional) 2-6 September 2024. The layout should be maintained as for 2020 at Bella Centre, meaning that the costs will remain essentially the same.

The budget has been revised.

The exact registration fees cannot be determined at the moment. The scientific committee will remain the same for 2024.

If EMC2024 takes place in Copenhagen, the current bidding process for 2024 would have to be cancelled.

Following are comments from the participants to the council meeting:

Grace Bruke: the predictions are difficult to assure since most meetings have been cancelled, so it will be difficult to assure the numbers today.

Kesara Anamthawat: SCANDEM will welcome EMC2024 and support this decision.

Jordi Arbiol: the Spanish society supports the decision of Klaus, the bidding has to be postponed, a decision has to be made on the already registered bids.

Josef Zweck: in case EMC2024 will be done in Copenhagen, it will not be possible to decide now on the 2028 bids. If the bidders will re-bid for 2028, they will be taken into consideration and may be prioritized.

Catherine Venien-Bryan: Sfµ supports the EMS board decision. What happens with virtual sessions.

Josef Zweck: it will be difficult to have a virtual meeting in August, but a session at the end of the year has been considered (October/November/December 2020). A platform will be used with a professional organisation for EMS members for the virtual meeting. Klaus Qvortrup: The format and date have to be decided by the EMS board. The abstract submitted for EMC2020 will be considered for the virtual meeting.

Vladislav Krzyzanek: Czechoslovak's society members suggested a virtual meeting due to the amount of work done already. If not possible, to maintain the competition for EMC2024 including SCANDEM.

Agnes Kittel: Hungarian society has decided to maintain the competition for EMC2024 including SCANDEM.

Josef Zweck: the vote today aims to determine if EMC2020 is postponed to 2024 or not, and depending on this decision, other options will be further considered.
