Many societies have been very helpful in providing data of EMS members in their country and we succeeded in updating the **EMS membershiplist** considerably. This list will be printed in the Yearbook. Regarding the **venue of EMC 2008**, we have no proposal yet and the present Executive Board is preparing a proposal to be discussed at the meeting in Antwerpen. 1. Agenda of the EMS GENERAL ASSEMBLY

to be held at EMC 2004 in Antwerpen (Thursday, August 26, 17,30 hrs), exact location to be announced at the registration desk of EMC 2004.

According to the Constitution, a General Assembly of all individual EMS members will be held during EMC 2004. The EMS is a European Society with over 3,000 individual members. It is important that EMS members gather, discuss and determine the framework in which they communicate and cooperate. <u>Summary of the rules</u>: All paid-up EMS members, including members of the Executive Board, have one vote. A quorum of 50 members is needed. The General Assembly will be chaired by the President of EMS. Decisions of the General Assembly are taken by a simple majority of votes. Two representatives of the Trade Committee have voting rights in the General Assembly.

Relative to point 11 on the agenda, we provide you with a summary of the CV's of the cadidates for the function of member of the Executive Board of EMS for the years 2004 – 2008

2. Summary of CV's of the candidates for the EMS Executive Board 2004 – 2008

Aebi, Ueli (candidate for President), born in 1946 in Bern **Switzerland**. Completed studies at Bern University in Physics (1972), master in molecular biology (1974) and worked in the Biozentrum, University of Basel, PhD thesis on "Analysis and biological significance of the structural state of ordered macromolecular assemblies when visualized in the electron microscope". Professor and director of the Interdisciplinary Microscopy Centre of the University of Basel. His main interest is the structure and function of molecular machines and supra-molecular assemblies with a focus on cytoskeleton, nuclear pore complexes and the formation of fibrils in amyloid depositions. He has positions for several years (1977 – 1986) in the University of California at Los Angeles and Johns Hopkins University in Baltimore. He is co-author of over 200 publications. He is involved in several companies producing surgical instruments, hip or knee replacements or pharmaceutical products. He is member of the Editorial Board of several journals and member of many scientific societies in the USA and Europe.

Brydson, Rik, born in 1963 in the **UK**, studied Chemistry and Mathematics in the University of Leeds (1985) and worked in the Department of Physical Chemistry, University of Cambridge and defended a thesis on "Electron energy loss spectroscopy (EELS) in solid state chemistry". He worked at the Fritz-Haber Institute in Berlin with Prof Zeitler. He had positions at the Department of Physics, Imperial College in London and the Department of Materials of the University of Oxford and the Department of Materials Science and Engineering of the University of Surrey. He is now Reader in the University of Leeds, where he coordinates the Electron-Optical Unit and conducts research in materials sciences with many students. He was invited speaker at many microscopy conferences and collaborates with numerous colleagues in the UK, USA and Europe. He is (co)author of many publications, many of which use EELS.

Carrascosa, Jose (Past-President), born in **Spain**, master in biological sciences Complutense University Madrid, PhD in Biology in the same university. EMBO fellow Biozentrum Basel, Switzerland (1976-1979), professor and head of the Department of Macromolecular Structure of the Centro Nacional de Biotecnologica (CNB) in the Universidad Autonoma, Cantoblanco Madrid. More than 150 articles in refereed journals and 15 chapters in books, member of the Editorial Board of several journals, member of many Organizing Committees of congresses and chairman of many sessions, chairman of many societies and committees in Spain and abroad. Research interest: high resolution electron microscopy and image processing of morphogenetic processes in viruses, protein folding and protein transport. **Cheynet, Marie**, born in **France**, PhD with a thesis "Nucléation homogène dans les métaux et alliages liquides" in the National Polytechnic Institute of Grenoble (1979). Position of research engineer at the National Centre of Scientific Research (CNRS) with research activities in the field of powder metallurgy and a private company (Pechiney Aluminium). Present position in the group Physics of Metals at the Laboratoire Thermodynamique et Physico-Chimie Metallurgiques in Grenoble. Research interest: the chemical, structural, physical and electronic properties of materials, mainly using VEELS.

Ginsel, Leo (Treasurer), born in 1947 in **Holland**, biology studies at the University of Leiden, PhD in the Faculty of Sciences in 1979. Appointments at the Lab for Electron Microscopy, Medical School, University of Leiden and professor in Cell Biology and Histology University of Nijmegen (1991). Research interests: lysosomes and transport in intestinal epithelial cells, monocytes and tissue macrophages, in situ hybridisation and tissue implants. Member of many committees concerning the education of biomedical students, (co)author of 127 publications.

Hawkes, Peter (Yearbook, 2nd Past-President), born in 1937 in the UK, master in physics and mathematics at the University of Cambridge (1959), PhD at the Cavendish Laboratory in Cambridge, positions at Cambridge and appointed 'directeur de recherche' of the CNRS in France 1975. Research interest in electron optics and electron image processing in the Laboratoire d' Optique Electronique (CEMES) in Toulouse, France, director in 1987. CNRS emeritus in 2002. Member of international organizations and member of the editorial board of many journals. Author and editor of 11 books and many articles in scientific journals.

Hertsens, Bob (representing Industry), born in Antwerpen, **Belgium** in 1953, Studies as lab technician, graduated in chemistry at the University of Antwerpen, PhD in Biochemistry with a thesis on "Ultrastructural investigation of mitochondria in the heart at different metabolic conditions". Undergraduate studies in the medical school of Antwerpen. 33 publications in international journals. Positions at the University of Antwerpen. Managing Director at JEOL (Europe) from 1987 onwards, in Zaventem, Brussels and Schiphol, Amsterdam.

Hozak, Pavel, born in Turnov, **Czechoslovakia** 1958. Studies in biology at the Lomonosov State University, Moscow and Institute of Experimental Medicine and Charles University in Prague. PhD in Cell Biology. Positions in the Inst. Experimental Medicine in Prague, Sir William Dunn School of Pathology University of Oxford. D.Sc in biology and medical biology in 2002. Professor and head of the Department of Cell and Molecular Biology of the Charles University Prague. Research interests: structure and function of the cell nucleus. 45 peer reviewed publications, many invited lectures.

Mayer, Joachim, born in Kirchheim, **Germany** in 1959. Studies in physics at the Technical University of Stuttgart. Dr thesis at the Max Planck Institute für Metallforschung Stuttgart with the title: "Phase transitions in Ni-Mo and quasicrystalline Al-based alloys: in situ investigations in the high voltage electron microscope". Positions at the College of Engineering University of California at Santa Barbara, Max Planck Institut für Metallforschung Stuttgart, professor at Aachen University, head of the central facility for electron microscopy, 84 publications.

Schryvers, Nick (candidate for Secretary), born in Antwerpen, **Belgium** 1959. Studies in Physics, University of Antwerpen, PhD in Physics "Order-disorder phenomena in the binary alloys Pt_xTi , Pt_xV ($3 \le x \le 8$) and Ni₃Mo studied by high resolution electron microscopy". Habilitation in Physics: University of Brussels, 1991 "An atomistic approach to the martensitic transformation in Ni-Al". Positions at the University of Antwerpen, and Lawrence Berkeley Laboratory, University of California (1987), professor of Physics University of Antwerpen. Many publications, invited lectures and functions in societies, committees.

Vittori Antisari, Marco, born in Rome, **Italy** 1950. Studies in Physics in the University of Bologna. Positions at the University of Bologna, researcher with the National Agency for New Technology, Energy and Environment (ENEA) at the Research Centre of Casaccia (Rome). Organizer of 20 summer schools and short courses, including conferences and congresses in EM. Research interest: the microstructure of materials and material performances, from hardened steel to nanophase materials, phase transformation by irradiation. Publications in books and journals.
