



Agenda of the GENERAL ASSEMBLY of EMS

To be held at the **21st International Microscopy Congress (IMC21) 2026** in **Liverpool, UK** on **Wednesday 2nd September 2026, at 12:10 (local time, BST), Room 3A** (in case of room change, members will be notified by email).

According to the Constitution of EMS, a General Assembly of all individual EMS members should be held at least once a year with the aim to discuss and determine the framework in which they communicate and cooperate. For details on the Constitution, see the EMS website: <http://www.euremicsoc.org>.

Summary of the rules: All paid-up EMS members, including members of the Executive Board, have one vote. A quorum of 30 members is needed. The General Assembly will be chaired by the President of EMS. Decisions of the General Assembly are taken by a simple majority of votes. Two representatives of ECMA (European Corporate Member Assembly) have voting rights in the General Assembly.
